9. Adoption of Forward Plan 2015 including Reports 2014, Budget 2015 and Special Projects 2015

Judith led a lightening tour of the Annual Report 2014 and Forward Plan 2015.

Barrow Voice: (Gaynor Barton)

Over the years BV has become more of a magazine than a newsletter and is going from strength to strength. In responding to a decline in number of advertisers we have had to reduce the number of pages but June's edition will be back up to 36 pages. Gaynor asked for more contributors and more photographers. She thanked John Nurse for his excellent work creating the BV website.

Events: (Betty Turner)

Betty commented that numbers of customers are going down for dances.

The murder mysteries are excellent. Centre Stage will continue for 2015/16.

Heritage Group: (Ginnie Willcocks)

It is now a very active group with 12+ members. Currently they are looking at farming in the village and will have an exhibition in the Round House in September.

Last year, they found so much information about the Holy Trinity memorials that the group has decided to publish a leaflet.

Panto Group (Ceri Fairbrother)

Last March's panto was very successful. We are delighted that the Youth Theatre is back on track and will be performing Disney's Little Mermaid in November.

Twinning: (Graham Hobbs)

23 visitors will be coming to Barrow in June for this year's exchange celebrating 20 year's of Twinning with Marans. The group would welcome new members and Graham reassured people that you don't have to be able to speak French.

Youth Action Group (Judith Rodgers)

Sadly the group has been disbanded. However, its need has more or less disappeared with the mounting success of the Tuesday evening Street4Life Youth Group run by the Carpenter's Arms, financed by the Parish Council. Between 20 and 30 young people often turn up.

Fossil Trail (Judith Rodgers)

There is now a new adult Fossil Trail leaflet which includes the ammonite sculpture on Sibley Road.

Special projects: see REport

Pauline Ranson proposed that they be accepted, Diane Thorpe seconded. All in favour.

Diane Thorpe proposed that Barrow Library become our Registered Address as soon as the transfer has taken place. Alan Willcocks seconded. All in favour.

10. Reports: i) on progress with BUSCA taking over the library as a Community Partnership Library

Brian Tetley: The LCC will be providing us with model policies (via VAL) that we can use as a template for the running of the library. We don't have to have sorted all the detail wording etc before the transfer; the deadline will be March 31st 2016. These will need to be approved by Trustees. See minutes of Trustees' meeting in later part of meeting.

The training of the library volunteers is about to start.

We are about to advertise for the Coordinator of Volunteers. The BUSCA website will have the job application on it for an on-line application. The advert will occur in the Neighbourhood Watch sheet and Barrow Voice and on posters.

David reminded those present that when the library is closed, BUSCA can use the building including hiring it out for other groups.

Jane Tindle commented that it will be really helpful for groups to be able to hold meetings in a building with full wheelchair accessibility and, eventually, a disabled toilet.

ii) on developments with the New Community Building project

Alan Willcocks

Looking at the BUSCA Constitution the aims fit clearly with both the Library transfer (Aim 1) and the New Community Building project (Aim 2). The project began in 2005. It was perceived that there was a clear need for a community building in Barrow. The NCB committee has initiated a feasibility study by consultants. We need an answer to question of whether to continue with 4 possible sites.

iii) on our solution to the closure of the leicestershirevillages Barrow website

John Nurse and Keith Butler

All the lv sites will be closed down in August 2016. In anticipation of this we have looked at various approaches to transferring the information that is on the BarrowuponSoar site and the Heritage site. This includes the possibility of transferring it to the Parish Council website which has a compatible structure. However, this has been abandoned because it is too restricting and would be expensive.

We have now decided to build our own site. It is a massive job and any help will be welcome.

2. Minutes of the Trustees' meeting on February 24th 2015

Alan Willcocks proposed the minutes be accepted as a true record; seconded by Graham Hobbs. All in favour

3. Matters arising:

4. Treasurer's report (Accounts from Jan 1st 2015) (David Rodgers, Treasurer)

Having approved the examined annual accounts for 2014 at the earlier AGM, Treasurer gave a verbal summary and commentary of the accounts from Jan 1st 2015 to Monday 1st June 2015. Comments: Income from the community bar continues to be affected by the increase in charges at the Community Centre. We may need to consider changing what is sold.

The final total from the March Panto is still not known because an invoice is outstanding. Ceri Fairbrother will chase this again.

Barrow Voice income from advertisers looks as though it is big enough to allow a 36 page magazine.

5. Community Centre update (Carol Westbury)

BOSCAPS will go ahead more or less as usual. School has compromised with the costings but this is to be a one-off situation.

6. Progress and further discussion on Special Projects

New edition of the Adult Fossil Trail leaflet: Total cost will be about £750 but Judith has secured sponsorship from Barwood Homes. They will be accepting the offer of the Welcome Packs for new purchasers.

The Village Map leaflet will be updated

7. Further report from BUSCA Trustees Library Committee (Judith Rodgers, David Rodgers, Alan Willcocks, Ceri Fairbrother and Ted Rodgers)

Alan reported that the BUSCA Trustees Library Committee have now received a draft of the LCC Grant Agreement document. This will be analysed by this Committee and by the Library Management Committee (to remind trustees, this latter is a sub-group of BUSCA). When they are all satisfied that the terms are correct and understood, it needs two signatures of BUSCA Trustees prior to sending it back to the LCC.

Shortly, a draft lease will also arrive for similar consideration. This too will need to be signed and sent to County Hall.

Pauline Ranson proposed that trustees delegate the necessary powers to sign the Grant Agreement and the Lease and any associated documents (such as State Aid waiver) to the BUSCA Library Committee. The BUSCA Library Committee is then to report to Trustees at the next meeting in September. Seconded: Frances Thompson. All in favour.

Alan Willcocks noted that BUSCA will need to modify its existing insurance cover with ANSVAR to cover all the requirements of the library transfer. This has always been overseen by David Rodgers and he will continue in this role. All agreed.

Alan Willcocks also noted that we would need to adopt a raft of new policies. Since we have been informed that we will be supplied with suitable templates to specifically cover library work, they should not interfere in anyway with policies adopted by those running other activities of BUSCA sub groups. We have a little more time to consider these. They will have to have been adopted by BUSCA Trustees by April 2016 as a prerequisite within the Grant Agreement before we can access any LCC funding.

The representatives of the Library Management Committee will bring to the next Trustees meeting in September an update of progress here, prior to their adoption by Trustees.

Alan reported for the BUSCA Library Committee on progress towards appointing a part time paid Co-ordinator of Volunteers. When the appointment is made, the contract will be with BUSCA Trustees. Ginnie Willcocks proposed that the BUSCA Library Committee has delegated powers to make this appointment and all necessary legal arrangements. Seconded by Betty Turner. All in favour.

Graham Hobbs proposed a vote of thanks to the five people who sit on the BUSCA Trustees Library Committee and to the 11 members of the Library Management Committee. All enthusiastically in favour.

8. Safeguarding and Child Protection (Val, Diane)

Diane outlined how she will go about organizing DBS checks. This sounds much quicker, more efficient and cheaper than the previous procedure. We currently have 4 members of the Youth Theatre needing renewal checks.
